Inhalation

Methods and Materials for Containment and Cleaning Up

Stop leak if possible without personal risk. Do not touch or walk through spilled material. Use water spray to reduce vapors or divert vapor cloud drift. Do not direct water at spill or source of leak. Remove all sources of ignition. If possible, turn leaking containers so that gas escapes rather than liquid. Allow substance to evaporate. Ventilate closed spaces before entering. Stay upwind and keep out of low areas. Damaged cylinders should be handled only by specialists.
